# Biographical Note by The HistoryMakers®

Building a better community in her adopted hometown of Long Beach, California, occupied Lillie Mae Wesley nearly all her life. Born in Texarkana, Texas, on June 11, 1921, Wesley spent her childhood in Texas. In 1942, she married Ovid Wesley, who served in the Army during World War II. As her husband prepared to leave the service in 1944, Wesley moved to Long Beach, where her sister lived. Wesley took the opportunity afforded by her husband's return to pursue an education. She began at Long Beach City College and later attended Pacific College before completing her studies at Long Beach State University, where she received a B.A. in recreation and human services.

Both professionally and personally, Wesley worked to help people, especially the less fortunate, in Long Beach. Her first job in California was with the Salvation Army, where she worked for eleven years managing distribution of used clothing and furniture to thrift stores around the area. In the 1950s, Wesley took a position with the City of Long Beach, working in the Department of Recreation. She served in several capacities, including outreach to senior citizens, before retiring in 1980 as supervisor of the Park District.

Outside of her career, Wesley actively and selflessly served her community through her church, St. Mark Baptist Church. With the help of her church and fellow parishioners, Wesley established the first storehouse for the elderly in Long Beach. She also helped elderly, illiterate blacks complete application forms and other paperwork to receive entitlement benefits.

Though she never sought special recognition for her outreach, Wesley received several citations and commendations for her service. She received the Employee of the Year Award from the city of Long Beach in 1980, was recognized by Los Angeles County on Older Americans Recognition Day in 1996, was awarded a certificate from the Family Life Foundation for her service to Long Beach families, and was congratulated by Congress for her life's work and service. In 1992, Wesley became the first black grand marshal in the history of the

Long Beach Inaugural Parade.

Wesley and her husband were married fifty-nine years. They have one daughter and one granddaughter. Wesley passed away on May 21, 2010.

## **Series I: Original Interview Footage**

Video Oral History Interview with Lillie Mae Wesley, Section A2002\_206\_001\_001, TRT: 0:30:00?

Lillie Mae Wesley describes her family background. Her father, James Butler was born in the 1880s in Arkansas. As a young man, he settled briefly in Ashdown, Arkansas before moving to Texarkana, Texas, where he met his wife, Sallie Sumerall. Sumerall was born in the 1880s, presumably in Texarkana, Texas. After marrying, Butler and Sumerall gave birth to their fourth child, Lillie Mae Wesley, on June 11, 1921. James Butler worked his way from day laborer to landowner. As a child, Wesley worked on her father's dairy farm, as well as on the family's traditional farm property. She also helped tend to her mother's flower garden, and enjoyed playing sports with local farm children. Wesley learned to play the piano and sew as a youth, as well. Wesley's parents enrolled her at Dunbar Elementary School, one faction of a three-part school in Texarkana, Texas, in the mid-1920s. Wesley talks about the rivalry between Dunbar High School and Booker T. Washington High School in Texarkana, Arkansas, as well.

Lillie Mae Wesley graduated from Dunbar High School in Texarkana, Texas in 1938. Afterwards, she helped her prominent farmer father, James Butler, manage the family's farm as he expanded it. She also attended Bishop College Extension School part time for one year. In 1942, Wesley married Ovid Wesley, and the two relocated to Long Beach, California in 1944 after he was discharged from the U.S. Army. Wesley helped her husband through his high school and college studies and Long Beach Polytechnic High School and Long Beach City College, respectively. Wesley obtained a two-year certificate from Long Beach City College, and later enrolled in California State University, Long Beach, which she attended part-time for twelve years. In the 1950s, Wesley was hired by the City of Long Beach Parks and Recreation Department. By the time her husband made her retire in 1980, she had risen to supervisor of the City of Long Beach Park District.

Lillie Mae Wesley chaired the Women's Auxiliary for the Long Beach branch of the NAACP. She worked with the group to raise money for the NAACP as they fought local discrimination cases, and attended the NAACP's national conferences. Wesley was also heavily involved in her church, St. Mark Baptist Church. After she retired from her position as Supervisor of the City of Long Beach Park District in 1980, Wesley enjoyed being a wife to her husband, Ovid Wesley. Wesley had an immeasurable amount of respect for her husband, and refused court anyone or re-marry after he passed away in 1996. Wesley talks about the importance of treating others well, as well as how she would like to be remembered. She close the interview by narrating her photographs.
