# Biographical Note by The HistoryMakers®

Donald "Duck" Porter was born in Chicago, Illinois, on November 22, 1936. The son of a teacher and a steel worker, Porter's family moved from Chicago to nearby Gary, Indiana, in 1951, where he finished high school in 1956.

The Spaniels, the musical group to which Porter would eventually belong, formed in 1952 along with Vee-Jay Records. Porter joined The Spaniels four years later, and continued to sing and tour with the group for the next three years. The Spaniels went on to become widely regarded as one of the greatest doo-wop groups of the 1950s, and their 1954 hit, "Goodnight, Sweetheart, Goodnight," was featured in several movies, including *American Graffiti* and *Three Men and a Baby*. Porter and the rest of the group toured the country with other popular acts, such as Little Richard and Chuck Berry, until the group disbanded in 1959.

Porter went to work for Acme Steel Company as a crane operator after The Spaniels broke up, where he remained until 1963; he spent the next decade working as a bookbinder. In 1973, The Spaniels re-formed and toured until 1988. After leaving the tour circuit, Porter worked as the head of security for the First Church of Christ, Scientist, in Boston; he also traveled the country, speaking about the music of the 1950s. The Spaniels reunited again to appear as the closing act of a PBS concert special, *Doo Wop 50: Celebrating Five Decades of Street Corner Harmony*; the special generated more money than any other PBS special to date.

In addition to his professional activities, Porter raised seven children.

Porter passed away on April 29, 2020.

# **Detailed Description of the Collection**

#### **Series I: Original Interview Footage**

Video Oral History Interview with Donald "Duck" Porter, Section A2003\_097\_001\_001, TRT: 0:31:21?

Donald Porter discusses his family background, detailing his relationships with his father, mother, and grandmother. Porter also describes growing up in Chicago and his subsequent move to Gary, Indiana, where he graduated high school. He recalls being a nondescript student who enjoyed English classes and foreign languages.

Video Oral History Interview with Donald "Duck" Porter, Section A2003\_097\_001\_002, TRT: 0:30:58?

Donald Porter recites lines from some of his favorite poetry, an interest he developed as a child with his father. Porter then describes his high school years

in Gary, Indiana, explaining how he was recruited to sing in the R&B group the Spaniels. Porter details the group's struggle with the recording industry, explaining how white groups and songwriters took credit and royalties away from black artists, including the Spaniels.

Video Oral History Interview with Donald "Duck" Porter, Section A2003\_097\_001\_003, TRT: 0:30:10?

Donald Porter describes the court case in which he and other members of the Spaniels sued for the right to collect royalties. He explains how the record industry exploited many black artists, and how many groups never received due credit for their achivements. Porter also talks about the Spaniels's breakup and subsequent reunion, as well as describing his life after retiring from the Spaniels.

Donald Porter discusses the differences between the current hip-hop music industry and the R&B music industry, focusing on the differences in record distribution. Porter also explains how gospel music and old spirituals formed the backbone for R&B and rock 'n roll. He considers his legacy and shares some of his own personal philosophy and faith. Porter then describes a series of photos depicting his life, family, and career.
