Abstract:	Psychiatrist Dr. Annelie B. Primm (1956 -) served as Director of the City Division of Springfield State Hospital, a Maryland psychiatric hospital. Primm also held a variety of positions at Johns Hopkins, including staff psychiatrist, associate professor and the Director of Community Psychiatry. Primm was interviewed by The HistoryMakers® on July 26, 2004 and September 22, 2004, in Baltimore, Maryland. This collection is comprised of the original video footage of the interview.

Biographical Note by The HistoryMakers®

Annelie Beneé Primm was born on January 26, 1956 in Geneva, Switzerland. Her mother was a music teacher and her father a physician. She lived in Switzerland until she was four years old while her father was attending medical school. After earning his medical degree, her father moved the family to his native New York. She grew up in the bedroom community of New Rochelle and graduated from New Rochelle High School in 1972.

Although she received an academic scholarship to the University of Virginia, Primm decided to attend Harvard-Radcliffe in Boston. She earned her bachelor's of arts degree in biology in 1976. Despite taking off the second semester of her junior year to help care for her mother who was dying of cancer, she graduated with her class. In 1980, Primm earned her medical degree from Howard University. After completing her residency in psychiatry at Johns Hopkins in Baltimore, she earned her MPH degree from Johns Hopkins School of Public Health in 1985.

While at Hopkins in 1985, she co-founded a program called COSTAR (Community Support Treatment and Rehabilitation), which provided in-home mental health treatment to patients. From 1985 until 1986, she worked as a psychiatrist at Provident Hospital in Baltimore. During this time she also worked as the director of the City Division of Springfield State Hospital, a Maryland psychiatric hospital. She also worked at Johns Hopkins Hospital from 1980 until 2004. She held a variety of positions at Hopkins including, staff psychiatrist, associate professor and the Director of Community Psychiatry.

In 1999, Primm produced a videotape called *Black and Blue* that highlighted depression in the African American community and encouraged minorities to seek treatment for mental illness. In 2001, she produced *Gray and Blue*, which helps senior citizens recognize and treat depression.

Currently, Primm works as the Director of Minority and National Affairs for the American Psychiatric Association. She also maintains a small private practice and is a psychiatric consultant to On Our Own, a drop-in center for

adults with mental illness. She is a fellow of the American Psychiatric Association and the recipient of numerous awards for her work in community psychiatry.

She lives in Baltimore, Maryland her husband, Herbert, and daughter, India.

Detailed Description of the Collection

Series I: Original Interview Footage

Video Oral History Interview with Dr. Annelie B. Primm, Section A2004_109_002_001, TRT: 0:29:26 ?

Dr. Annelle B. Primm was born on January 26, 1956 in Geneva, Switzerland. Her mother, Annie Delphine Evans Primm, was born in 1930, grew up in Fayetteville, North Carolina, and attended Fisk University. Primm's father, HistoryMaker Dr. Beny J. Primm, was born in Williamson, West Virginia and raised in the Bronx, New York City. He graduated from West Virginia State College. Both of Primm's grandmothers had master's degrees and were teachers. Primm's parents met while her father was stationed at Fort Bragg, North Carolina and moved to Switzerland where her father completed medical school at Geneva University. At age three, Primm won a televised hula-hoop contest in Switzerland. Primm remembers her two younger sisters; her family's Christmas celebrations where they would sing and her mother played the piano; and attending school in Huntington, New York where she was the top student and the only African American student in her classes. When she was ten years old, her family moved to New Rochelle, New York.

Dr. Annelle B. Primm attended elementary school in Huntington, New York on Long Island. She was interested in medicine because of her father's, HistoryMaker Beny J. Primm's, career and identified her interest in psychiatry from a young age. In 1966, her family moved to a middle class African American neighborhood in New Rochelle, New York where she was active in a Presbyterian youth group and attended Isaac E. Young Middle and New Rochelle High School. She was a cheerleader at both schools and played flute in the school band. Primm graduated high school in 1972, at the age of sixteen, and matriculated at Harvard-Radcliffe College in Cambridge, Massachusetts. Although, her freshman year was the first year women were allowed to live in Harvard Yard, she lived on the Radcliffe College campus. She credits Assistant Dean David L. Evans with fostering a supportive black Harvard-Radcliffe community. Her mother was diagnosed with breast cancer during her freshman year and passed away during her senior year.

Dr. Annelle B. Primm remembers the cohesive African American community at Harvard-Radcliffe College in Cambridge, Massachusetts. After her mother died in 1976, during her senior year of college, Primm helped to care for her two younger sisters while she attended Howard University College of Medicine in Washington, D.C. In medical school, Primm considered specializing in obstetrics and gynecology but eventually choose to enroll in a psychiatry residency program at Johns Hopkins University. She also completed her M.A. degree in public health at Hopkins and in 1985 co-founded COSTAR (Community Support Treatment and Rehabilitation), the first support program in an urban setting for individuals with severe mental illnesses, as part of her fellowship. Primm talks about health disparities and the stigma around mental illness in black communities, as well as the religious community's resistance to mental health services. In 1999, she produced 'Black and Blue,' a video series on depression in the black community.

Dr. Annelle B. Primm talks about misdiagnoses of mental illness and other barriers to mental healthcare in the African American community, such as the high costs. She believes that anxiety disorders are underdiagnosed in the African American community and schizophrenia is often misdiagnosed; that African

American celebrities' discussion of their struggles with mental illnesses is useful in combating stigmas and encouraging people to seek treatment; and, that there need to be more African American psychiatrists. Primm shares advice for young people interested in mental health careers and reflects upon her life, her legacy, and how she would like to be remembered. Primm concludes by narrating her photographs.
