## Biographical Note by The HistoryMakers®

Celebrity photographer David Bodrick was born on July 31, 1963 in Brooklyn, New York. His mother was a teacher, his father a contractor. Bodrick was educated in the New York City public school system. In 1980, during his sophomore year at high school, he became a teenage father. After earning his diploma from James Madison High School in 1982, he began working full time as a messenger on Wall Street.

Over the next several years, Bodrick held several temporary jobs on Wall Street until he landed a full time position at Nippon Credit Banking. While working at Nippon, Bodrick earned his B.A. degree in film in 1988 from The School of Visual Arts in New York. In 1992, he began producing a cable show highlighting fashion and music trends in New York City. He also worked as a production assistant for MTV.

In 1995, Bodrick and his younger brother, Jonathan, started DMBJ Productions, a company which photographs and videotapes celebrities. His agency, known for celebrity footage, has often been the first to publish photos of famous couples.

Bodrick lives in New York City. His son, David III, is a producer at DMBJ Productions.

## Detailed Description of the Collection

### Series I: Original Interview Footage

Video Oral History Interview with David Bodrick, Section A2005\_034\_001\_001, TRT: 0:29:56 ?

David Bodrick was born July 31, 1963 in Brooklyn, New York, New York. His mother, Marie Bodrick, was born in Kinston, North Carolina, attended Shaw University in Raleigh and moved to New York City to pursue her teaching career. His father, David Bodrick, Sr., grew up in Lone Star, South Carolina on a farm. His father was a headhunter. He followed his two older brothers to New York City to find a job and, after working as a laborer, became a contractor. Both of Bodrick's grandmothers were single parents. His paternal grandmother, Angie Bodrick, lived with his family in Brooklyn growing up. As a young child, he almost burnt down his house while playing with his brother, Johnathan Bodrick. On a typical day, he played with his brother and sister, Vanessa Bodrick Davis. His neighborhood was full of row houses, and children often

played in the streets. For most of his youth, his family was Jehovah's Witnesses. He attended P.S. 155 for kindergarten through third grade and P.S. 193 for fourth through sixth grade.

David Bodrick was bused to school starting in fourth grade as part of New York, New York's desegregation efforts. In elementary school at P.S. 193, he struggled academically and faced racism from his peers. He was shy and, although raised as a Jehova's Witness, did not feel connected to the religion. He preferred painting and playing games with his neighborhood friends. At J.H.S. 278 Marine Park, he also encountered racism and started skipping school and using drugs, though he dreamed of eventually working on Wall Street and living in Manhattan. Bodrick became more popular when he attended James Madison High School. His son, David Bodrick III, was born during Bodrick's sophomore year, which made him focus on school. Although Bodrick and his son's mother drifted apart, their families were supportive of them as young parents. After high school, he worked as a messenger at a brokerage firm. He was encouraged to work for a temporary agency to gain greater exposure to different companies where he might be hired.

David Bodrick wanted to work on Wall Street after graduating from James Madison High School in New York, New York, so he started working temporary jobs for a handful of firms. He eventually was hired full time at Nippon Credit Bank. Bodrick wanted to pursue his artistic interests, even though he had to remain in a corporate job to financially support his son. He enrolled in night classes at the School of Visual Arts in New York City. While in film school, he created and produced the show 'Avant Garde.' After graduating with a B.A. in film in 1988, he took a six-month leave from Nippon Credit Bank to work for MTV. When he returned to Nippon, he was wrongly fired. The settlement from his former employer enabled him to start his own company, DMBJ Productions. He began shooting b-roll, or supplemental footage, for 'Video Fashion' and 'Fashion File' at various fashion shows. After 'A Current Affair' paid him for footage of Naomi Campbell, he began to sell video and photos of celebrities to popular tabloid shows.

David Bodrick explains the process for photographing or capturing video footage of celebrities, the ethical dilemmas of such work and his own boundaries and principles that guide him in the business. Though he sees a growing demand for footage of celebrities of color, the number of African Americans and non-white photographers has been stagnant, which leads to black photographers being restricted or discriminated against in the industry. At the time of the interview, his favorite celebrities to shoot included Jennifer Lopez and Oprah Winfrey. Bodrick explains what makes some celebrities photogenic, even in situations where they are not made up for the camera, and the commercialization that celebrities and celebrity photographers engage in as part of their careers. Bodrick reflects upon his life, career choices, and the importance of history. He offers advice for his son and for young people interested in celebrity photograph and videography and describes how he hopes to be remembered.
