Abstract:	Environmental engineer Jacqueline Sales (1946 -) , the first African American woman environmental engineer hired by the U.S. Environmental Protection Agency, is the founder and president of HAZMED, Inc. Sales was interviewed by The HistoryMakers® on May 24, 2013, in Lanham, Maryland. This collection is comprised of the original video footage of the interview.

Biographical Note by The HistoryMakers®

Environmental engineer Jacqueline White Sales was born on May 8, 1946. She graduated from Howard University with her B.A. degree in microbiology in 1968, and her M.S. degree in environmental engineering. Upon graduation, Sales served as director of the Georgetown University Rheumatology Laboratory at the District of Columbia General Hospital.

In 1979, Sales became the first African American woman environmental engineer hired by the U.S. Environmental Protection Agency (EPA). While there, she worked at EPA headquarters in Washington, D.C. and was assigned various scientific and public policy roles that involved writing and implementing federal regulations that protect human health. Sales' efforts at the EPA between 1979 and 1989 helped safeguard the environment from the improper disposal of toxic and infectious materials, and hazardous wastes. Sales also served in the U.S. Department of Energy (DOE) where she managed and directed the development of policy guidance documents for DOE Headquarters and field offices. In addition, she worked closely with the assistant secretary of Environment, Safety, and Health where she developed strategies for regulatory compliance and environmental restoration at contaminated sites.

In 1988, Sales became the founder and president of HAZMED, Inc. While there, Sales focus was on developing and implementing federal regulations, policies, and strategies for the management of hazardous, radioactive, and medical wastes; and for the cleanup of contaminated sites. She has guided waste management policies for federal, state, and local agencies, congressional staff, and industry; addressed media inquiries; participated in congressional hearings, and chaired national and regional waste forums. Sales served on the Foundation Board of Bowie State University, the Foundation Board of Doctors Community Hospital in Lanham, Maryland, and the Prince Georges Suite Magazine Advisory Board. She is the owner of the Johnson Browne Business Center for new and emerging businesses.

Sales was recognized by the EPA, who honored her with both the Bronze Medal and the Women in Science and

Engineering Award. She also received the Outstanding Woman in Scientific and Technical Careers Award from the United States Congress. In 2003, The Network Journal: Black Professionals and Small Business News named Sales as one of the “Top Twenty Five Influential Women in Business.” Under her leadership, HAZMED was named “Maryland Top 100 Minority Business Enterprises.”

Jacqueline Sales describes her mother's family, who came from St. Croix in the Virgin Islands of the United States. She discusses the Fire Burn Rebellion on St. Croix and how her grandfather came to the United States. Sales describes

how her mother, Lillian Augusta Browne, grew up in New York City, New York and met her father, Thomas Nathaniel White. After they married Sales' father was deployed in New Guinea during World War II and he returned in 1945. Sales was born a year later. She describes her parents, their personalities, and who she takes after. Her mother was a registered nurse and her father was an engineer, a night club owner, and a radio host. Sales shares her earliest memories and the sights, sounds, and smells of her childhood.

Jacqueline Sales describes her schools in Copiague, New York. She was one of three students to be on the college track and did well in her courses. Sales was involved in the Girl Scouts and her family was close-knit. Sales remembers her family's outdoor activities, which helped form her love of the outdoors. Sales' father, Thomas Nathaniel White, was a member in the National Association for the Advancement of Colored People (NAACP) and took her to the first March on Washington in 1941. Sales describes her decision to attend Howard University, Washington, D.C. At first her father opposed her decision because he wanted her to attend New York University, New York, New York, but he eventually agreed to let her go to Howard University. Sales talks about how she enjoyed her time at Howard University.

Jacqueline Sales discusses her years as an undergraduate at Howard University, Washington, D.C., where she majored in microbiology and was one of the few women on the pre-medical track. Her father, Thomas Nathaniel White, died in 1966 at the age of forty-five. Sales married her first husband that same year. She had her first daughter in 1968, shortly after graduating from Howard University. She discusses the assassinations of President John F. Kennedy and Dr. Martin Luther Kings. Sales' husband left her and she had to enter the work force as a rheumatology laboratory manager to support her daughter. After six years of work Sales decided to attend Howard University for a M.S. degree in environmental engineering, which she obtained in 1975. Sales talks about the Environmental Protection Agency and how she began to work with the organization.

Jacqueline Sales describes working for the Environmental Protection Agency and writing hazardous waste regulation. She specialized in hazardous medical waste. Sales moved from the Environmental Protection Agency to the Department of Energy to assist in the clean-up of nuclear waste around the United States. She began her own company, HAZMED (Hazardous and Medical Waste Services), in 1988 which subcontracts hazardous and medical waste clean-up. Sales describes the success of HAZMED and the challenges facing STEM-oriented businesses. Sales recalls the Anne Burford scandal in the Environmental Protection Agency.

Jacqueline Sales discusses some of HAZMED's past projects, including hazardous waste sampling and analysis plans for the Department of Energy and nuclear waste clean-up in the Rocky Flats Plant in Denver, Colorado. In 1993 Jacqueline Sales participated in the National Security Seminar at the United States Army War College in Carlisle, Pennsylvania. Sales describes how HAZMED has grown and diversified its services to include national defense and records management. She talks about her work as a member of the board of Bowie State University in Bowie, Maryland. Sales also describes her favorite HAZMED project, which involved hazardous waste clean-up in a remote area of Alaska.

Jacqueline Sales describes the facilities of HAZMED, her company, as well as the partnership it had with Boeing. Sales serves as the chair of the board of Bowie State University in Bowie, Maryland. Sales is married to Gregory Davis, the chief operating officer of HAZMED, and has four children and nine grandchildren. Sales reflects on her life, her legacy, and how she would like to be remembered. She gives her hopes and concerns for the African American community and offers advice for those interested in STEM fields.
